

# Canadian Petition regarding high altitude aerial spraying January 2013

*Please note that this cover page is for information purposes only and does not form any part of the Official Petition.*



This Petition, conforming to the requirements of the Canadian Government, is to be presented to the House of Commons. It concerns the spraying of unknown chemical or biological substances by certain entities flying at high altitude leaving behind long white plumes or trails which do not fade away as traditional aircraft condensation trails might but instead dissipate into large cirrus-like cloud formations or overcast.

This spraying in our skies has come to be known as “*chemtrails*” – a word now defined in the current *Oxford English Dictionary* plus a word to be found many millions of times via a *Google* search.

Over the last ten years or more many people have reported health problems as a result of this spraying such as persistent hacking coughs, upper respiratory and intestinal distress, disorientation, aching joints and muscles, nosebleeds, diarrhea, and many other, often flu-like, symptoms.

Please read and join in signing this Petition, which is drawn up to meet the requirements for presentation to the House by a Member of Parliament. The prayer, or request, contained in the Petition has been reviewed by Jacques Maziade, Procedural Clerk and Clerk of Petitions, House of Commons, and found to meet the official requirements.

For those gathering signatures print or photocopy as many sheets as you may require from the PDF file. Note that the pages must be free of erasures and contain only original signatures and addresses written directly on to the petition. Names will not be used in any way other than for the purposes of this Petition.

Any number of signatures on a sheet is acceptable as all will be gathered together in total before submission. Young people may sign as long as they understand what they are signing and requesting.

# PETITION

## TO THE GOVERNMENT OF CANADA

**WE**, the undersigned residents of Canada draw the attention of the Government of Canada to the following:

THAT high altitude aerial spraying has been observed occurring throughout Canada for many years and continues to this day;

THAT this aerial spraying is being carried out by aerial entities at high altitude that create long lasting plumes that do not act as traditional aircraft condensation trails with informed observations indicating that these plumes are laden with a wide variety of unhealthful matter. These long lasting plumes in the sky have come to be widely, commonly and generally referred to as "chemtrails" - that is, according to the current *Oxford English Dictionary*.

THAT these plumes eventually disperse widely and the contents therein drift down in the atmosphere so adversely affecting the health of the population at large;

THAT this aerial spraying is being carried out without the knowledge or consent of the People of Canada;

THAT all citizens have the inalienable right not to be sprayed from the sky in this manner for whatever purpose that such activity may be;

**THEREFORE**, your Petitioners call upon the Government of Canada to take the following actions:

- (1) to fully inform the People of Canada about this aerial activity occurring high in our skies and to explain why this spraying is being allowed to take place;
- (2) to cause this aerial activity to cease forthwith.
